## OTHER CHARGES:

### Year 6 Camp

The cost of the Compulsory Year 6 camp for 2018 will be \$300 per student.

**Amenities Fee** – An additional fee per student per annum is charged to cover the cost of art and craft materials, photocopying of classroom work sheets, book sets and other materials required. It also includes computer levies, insurance, swimming, excursions and incursions throughout the year. For Kindergarten this also includes speech and occupational screening.

**\*\* Please note that if you have a child in Year 4, the Amenities Charge will be \$560 per student as opposed to \$510 per student. The difference being an extra \$50 for a 1:1 ipad lease over 3 years with an option to purchase the device outright at the end of lease.**

**\*\* Please note that if you have a child in Year 5, the Amenities Charge will be \$555 per student as opposed to \$510 per student. The difference being an extra \$45 for a 1:1 ipad lease, this being the 2nd year of a 3 year lease. There is an option to purchase the device outright at the end of 2019.**

**\*\* Please note that if you have a child in Year 6, the Amenities Charge will be \$610 per student as opposed to \$510 per student. The difference being an extra \$100 for a 1:1 ipad lease, this being the final year of a 2 year lease. There is an option to purchase the device outright at the end of 2018.**

**Education Packs** – A component of your Annual School Fee Invoice is your child's Education Pack. This pack includes many necessary aspects which will enable your child's teacher to deliver a full and comprehensive curriculum. Stationary items will be made into Book Packs and will be distributed by the classroom teacher. This includes Mathletics and Spelling Mastery.

## **TERMS OF PAYMENT**

School fee accounts will be issued once a year in February. These will be handed to the eldest child to take home in their school bag. Payment options are:

- Option 1** Pay the full amount of school fees by March 2 2018 and receive a 5% discount.  
*(On Tuition Fees ONLY and not applicable to HC Card Holders)*
- Option 2** Fees payable in four equal instalments, the first payment being due 2 March 2018, the second instalment will be due 25 May 2018, the third instalment due 10 August 2017 and the final instalment due 26 October 2018.
- Option 3** Pay the full amount in regular instalments via Direct Debit between February and October. The instalments that are paid will need to pay off the full amount of fees no later than Friday 26<sup>th</sup> October 2018.

## **APPLICATION FEE**

In order to register a student for enrolment, an enrolment form must be completed which includes an administration fee of \$35.00. This fee is non-refundable and does not guarantee enrolment.

## **ENROLMENT ACCEPTANCE DEPOSIT**

An acceptance fee of \$50.00 is payable once an offer of enrolment for each child has been made. The fee is non-refundable however is credited against the school fees.

## **NOTICE OF WITHDRAWAL**

One (1) terms notice in writing must be given prior to the withdrawal of a student, otherwise a full term's fee will be charged. Accounts need to be finalised prior to leaving the school.

**PLEASE NOTE:**

**Health Care Card Holders**

It is essential for Health Care Card holders to complete the necessary forms immediately to be eligible for the tuition fee discounts. Health Care Cards and Pension Cards must be current or fees will be adjusted. You must bring in new cards as they are received from Centrelink. Discounts will only be applied from when the card is received, it will not be retrospective.
